A pair of spaced-apart wheels is mounted to a frame which is adapted to support the seat in an upright position. The wheels are each supported by their own set of bearings which are mounted in the frame. It has been recognized that a weight distribution of the carriage which is supported on two wheels is substantially different than a weight distribution of a carriage which is supported on one or more wheels.
